

**ORDINANCE NO. 2007-08**

**ORDINANCE ACCEPTING GREEN STREET INTO THE COUNTY ROAD SYSTEM.**

WHEREAS, the Hopkins County Fiscal Court on its own Petition has expressed the desire to bring into the County Road System a public road named Green Street, which is described with more particularity as 601 feet long and 16 feet wide, GPS 37.23 169N 087.38 286W..

WHEREAS, two viewers were appointed by the Fiscal Court together with the County Road Supervisor, who viewed the proposed road establishment and reported in writing to a public hearing held on July 11, 2007.

WHEREAS, their report stated that the advantages which will result to the individual and public are: "There are eight homes on the road and it meets minimum county specs; no maintenance is needed at this time."

WHEREAS, the Hopkins County Fiscal Court finds that establishment of the subject road is in the public interest in the following respects: (1) There are eight homes on the road and it meets minimum county specs; no maintenance is needed at this time.

NOW THEREFORE, BE IT ORDAINED by the Fiscal Court of Hopkins County that the above-described public road named Green Street shall be brought into the Hopkins County Road System.

This Ordinance shall become effective upon publication.

First reading of this Ordinance was held on August 7, 2007.




